 - Participants find the Patient Persona helpful, but insist it needs to be longitudinal through the entire spectrum of care

- The St Louis University Mental Status (SLUMS) Exam is used at the same level as MOCA & MMSE
- Mini Cog is another screening test for cognition
- Focus on executive function is still missing
- All Cognitive Assessments listed in the slide deck are screening for cognition, not necessarily an assessment of cognitive function
- From the slide deck list, CAM is the most standardized screen across healthcare (acute and post acute)
- As a best practice, start with the CAM to first rule out delirium before proceeding with any other cognitive screening
