1) **Functional Status: Clinical Item Discussion** (Matt E., MaxMD) (45 mins)

- Group continued discussion from last week, focusing on the Patient functional exchange of data.
- Group discussed the definition of “Goals” that may impact functional status include:
 - Patient centric goal (brings together clinical and patient); priority of goal to patient and clinician (data standard to support this); goal attainment (status); D/C goals from setting, long term for entire episode of care; time duration for the goal should be achieved
- Group discussed the definition of “Care Plan” that may impact functional status include:
 - D/C Disposition (support, setting, safety; follow-up interventions, etc.
- FHIR and ELTSS have a care plan resource; it is important not to create several different versions of this as it creates interoperability problems.
- The group should continue to focus on what currently exists, examine what gaps are missing, and focus on filling in the necessary gaps.
- Request for someone from the ELTSS team walk through the goals and care plan information.

- 5) **Cognitive Status: Binding to Value Sets** (Rob S., ESAC) (40 mins)
 - Refer to “PACIO Project_Cognitive Status Mapping_v02.xlsx”
 - Group continued to discuss the parent and child relationship of data within the spreadsheet.
 - Regarding the medication list, will need to know the current and active medications and recent changes in medications. It would be optimal to know the start date of the new medications.
 - Cognitive assessments over time—would be beneficial to know the medications taken at the time of the assessment, although will be very difficult to determine.
 - May consider pairing assessments to the medication start date.
 - Group discussed the LOINC codes and the potential to use the responses as a codable concept and then reference the score.
 - Important to consider the method with the least extensions.
 - Group discussed reviewing FHIR mapping to see how it would line up to the questionnaire.
 - Important to consider—what would you want to query, specifically seeing how the patient is doing over time.
 - Spreadsheet will be sent out to the team. Group will continue to review the spreadsheet to consider how to relate to FHIR mapping.
