	Recap Alerts IG Goals	<ul style="list-style-type: none"> • Not doing a full V2 mapping for all scenarios • Covering minimally required information for Admits and Discharges • Common object of exchange for push/unsolicited notifications and subscriptions <ul style="list-style-type: none"> • Should be same regardless of reason for alert • Enough information for receiver to determine if alert is of interest • Enough information for receiver to ask for more information

	Rationale for Revisiting Approach to Alerts	<ul style="list-style-type: none"> FHIR Messaging intended to handle communications between organizations who don't have business relationships with each other Any technical differences between approaches? <ul style="list-style-type: none"> Concept of addressing a message to its final recipient using Messaging (MessageHeader type of information) Transport mechanism doesn't have to be a RESTful interface Content model - same information using MessageHeader as the first resource to define the event /content Communication is intended to be a record of a communication, not the communication itself - though it has been used to be the communication itself Messaging was intended to be the 'wrapper' for a message going somewhere May test Communication and Messaging in Connectathon Not advocating that someone switch from V2 messaging to what we're doing <ul style="list-style-type: none"> We're not trying to map V2 to FHIR External, inter-organizational broadcast that an event has occurred - not replacing any internal infrastructure This is a way of extending event notifications for non-connected parties without needing to put in place V2 messaging infrastructure Few payers have a V2 connection with every single provider that sees one of their members If payer is notified via V2 message that patient was admitted, this would be the way the payer would notify the PCP or other members of the care team Notification of other future events don't have an existing infrastructure except for ADT, public health, lab When we implement the Alerts IG, will we meet the Transitions of Care HEDIS measure? <ul style="list-style-type: none"> Measuring that the PCP or ongoing care provider was notified of the admission If the sender doesn't know who the members of the care team are, they can send the notification to the HIE or to the payer, who could then send to patient's care team If discharging institution sends notice to HIE saying patient has been discharged, and HIE sends to care team - what documentation is needed that this has occurred? Would need to look at the metadata required in the measure - guessing this doesn't include all the data needed Communication is best if you have both ends identified - sender and receiver If sending to HIE, Messaging or Communication, we don't know if the intended receiver got the notification If a significant part of what we're doing is to keep a record of what happened, then may need to use Communication to satisfy that need Messaging may be mechanism going from point A to point B, but Communication to keep a record that we did it? Gini McGlothlin to follow up with Ben Hamlin to ask him to weigh in There are likely other measures that might have implications IG should restrict transport paradigm - SHOULD use FHIR \$process-message operation <ul style="list-style-type: none"> May become SHALL in the future 	
	Review FHIR Messaging Artifact	<ul style="list-style-type: none"> Communication allows you to have more recipients <ul style="list-style-type: none"> MessageHeader doesn't have Patient or Related Person (you can't declare the patient as a receiver) MessageHeader.Focus is limited - subject line of an email, trigger event, what's being changed <ul style="list-style-type: none"> Focus doesn't tell you what's in the bundle MessageDefinition - defines what's in the message (particular bundle) and what's in the focus MessageHeader doesn't point to all the resources in the bundle
