	PDex Ballot Comment Review	<p>#23289</p> <ul style="list-style-type: none"> • Patients should be able to say don't disclose family history and psychiatric information • There are records that already exist and don't have security labels on them • At point of disclosure, apply security label • 42 CFR and state laws require this • Member authorization to disclose/Right of Access • This is under the patient-everything section (3-4-3) • Need to separate member-authorized vs. non-authorized
